Water feature matters

Wind Sensors

The anemometer (wind sensor) at the top of Leg 2 (the central spoke of the anchor leading up to the outer harbour), has now been replaced and along with those on Legs 1 and 3, is fully working. When the wind speed reaches roughly 20 mph the water jets and cauldron pumps will stop running for around two hours.

The purpose of the anemometers is to prevent water being lost through evaporation when it is blown into the air and onto the paths during high winds and storms, and passers-by being drenched.

Algae bloom

The prolonged June heatwave followed by sudden heavy rain at the tail end of the month resulted in a chemical imbalance of the water, leading to an unexpected and rapid bloom of algae. To resolve this, the water was heavily treated (or "shocked") with 50 litres of liquid chlorine (bleach) to kill the algae, followed by the addition of an alkalinity raiser to correct the imbalance. The following is an extract from the internet, which explains pH and alkalinity in keeping water conditions stable.

"pH is extremely sensitive and can quickly be thrown out of balance by temperature changes in the water, not to mention foreign substances such as rain, debris and even bodily waste. The solution to maintaining your pH level is to add a pH buffer, which is exactly what alkalinity increasers are. You can almost think of alkalinity as adding a layer of armour to your pH, absorbing fluctuations and keeping your pool chemistry stable."

Safety

It is appropriate to mention at this point that the addition of around 50 litres of chlorine to the water could make anyone swallowing the water rather sick.

Children and young people should be encouraged not to paddle or swim in the Water Feature. The steps of the structure are extremely slippery, especially when wet. The supporting side walls are intended to act as a barrier between the path and the water, rather than as an alternative to the path.

Parents of small children should take extra care to make sure their children do not run so far from them that they cannot see them or reach them quickly should they fall into the water.

In accordance with the Memorandum & Articles of Association, each property is allowed ONE vote irrespective of the number of registered owners (in the case of multiple or joint registered owners).

Any members wishing to join the board of the company will have the opportunity to do so by completing a nomination and acceptance form which will accompany the AGM paperwork. Please consider taking an active role in the management of the company that manages the Water Feature.
